Can I seek for sponsorship by a private company?	We have approved private companies to be sponsors of artworks in the past. However, the details of the sponsorship need to be discussed with the Setouchi Triennale Executive Committee if your proposal is accepted.
Will you assist the artist in finding accommodation to stay and do you cover the transportation or commute between the accommodation and the artwork's venue?	You will be granted JPY500,000 to 2,500,000 of budget for producing artwork from the Organiser if your proposal is accepted. However, no extra expense will be covered by the Organiser other than the allocated budget and therefore accommodation and transportation expenses should be included in the proposal should you think they are necessary.
Do you cover the airplane tickets and hotel expenses? If yes what is the maximum days of stay you can provide? If no, do we have to include these costs to our budget?	You will be granted JPY500,000 to 2,500,000 of budget for producing artwork from the Organiser if your proposal is accepted. However, no extra expense will be covered by the Organiser other than the allocated budget and therefore accommodation and transportation expenses should be included in the proposal should you think they are necessary.
Do you offer the artist an assistant, or do we have to include an assistant's salary and expenses to our budget?	You will produce your artwork with support from volunteers and local residents if your proposal is accepted. However, we won't be able to arrange an exclusive assistant to you and you should therefore allocate budget relating to expenses for your own assistant.
